In 2022 at least 35,015 students across 22 regions interacted with the program with 1,925 students competing at the regional level. 761 students competed at Texas History Day in Austin. The Symposium features a moderator and five to six speakers, each of whom have 35 to 40 minutes presentations, followed by a question and answer session.
