in 186 countries. TSHA PRESS. TSHA Press has published unique books about Texas history since 1918 with more than 150 books produced in print and in electronic form. TSHA Press is a founding member of the Texas Book Consortium, based at Texas A&M University Press. Annual sales exceed 4,000 paper, audio, and digital books per year. TEXAS ALMANAC. In publication since 1857, The Texas Almanac is valuable source for maps, charts, and data on Texas counties, cities, demographics, weather, agriculture, and much more.

The Symposium started in 2001 with each event featuring a specific historic theme. The Symposium is a two day event held in Houston during April each year. The Symposium features a moderator and five to six speakers, each of whom have 35 to 40 minutes presentations, followed by a question and answer session.
